Inspection done with Supervisor Diane Buhl, Cole Warminsky and Kristen Donmoyer.....viewed 2007 license.....

21.21a maintenance- warning- owner needs to repair any wire that is damaged, remove any items that could cause injury to the dogs

21.21b water resistance- warning- owner needs to paint/seal/cover any exposed wood

21.23a run space 21.23b run dimensions- charges to follow- owner needs to have runs that allow dogs to turn around freely, stand erect, sit and lie down in comfortable and normal position, also have runs that follow the kennel regulations guidelines

21.24d rest area- warning- owner needs to replace all wire that vinyl coating is being removed

21.28a food 21.28c food/water receptacles- charges to follow- owner needs to check food daily to see that it is not contaminated by feces/dirt/debris, also to see that food is not caked and owner should sanitize feeders often.

21.29a excreta- charges to follow- owner needs to remove feces daily from below primary enclosure and as from inside primary enclosure

21.29b sanitation- charges to follow- owner needs to sanitize primary enclosures daily making sure to remove feces/dirt/debris

21.29c housekeeping/pests- warning- owner needs to remove minor cobwebs in primary enclosures and mouse droppings that are on top of dog boxes

21.41a records kept- warning- owner needs to see that all dogs in kennel at time of inspection are on records

455.8 rabies vaccination- warning- owner needs to see that all dogs over 3 months of age are vaccinated and on records, also owner needs to keep rabies vaccinations on state record forms

recheck will be done at later date to see that problems are corrected.....
