Re inspection to make sure prior unsatisfactoriness have been corrected. At the time of inspection there were 198 adults and 30 puppies on the premises. Owner sells wholesale, has an exemption to keep records on usda forms. Owner can not find his rabies self certification letter. 21.21a maintenance, there are alot of broken wires and areas where the wires are not attached to the flooring of the cage. Dogs could slide there paws through the opening. 21.28a & c food and food receptacles, there was hair, mold, debris, flies, and a spider found in the feeders. 21.29a excreta, there was a cage in the whelping room housing a few puppies that had an excess of feces in it. 21.29b sanitation, there was hair and debris built up on the top, sides, and inside of cages in whelping area. There were cob webs all over the place. There was also urine, feces, and debris built up along the edges of inside of cages and along the crossrails, as well as between the door openings. 21.29c housekeeping/ pests, there was an excess of cob webs, spiders, flies, and also two dead rats found in one cage housing adult dogs.

Remark <p>Re inspection to see if owner is making any progress on fixing prior unsatisfactorities. There was 193 adult dogs and 42 puppies on the premises at the time of the inspection. 21.21 a, there are still alot of wires that need to be fixed, feeders that have sharp edges, and the area where the wires are not attached to the floor and sides of cage are still the same. 21.24 d, the coating is coming off the wire flooring in many enclosures. 21.28 a and c, the feeders had rust, mold, cob webs, deterioration, and are broken and some have sharp edges. One of the feeders from the previous inspection that the owner was told to clean that had mold in it was exactly the same during this inspection. 21.29 b, There was hair, debris, urine, and feces smeared along the cross rails and edges of the primary enclosure and also in between the cage door openings. 21.29 c, There was dust, cob webs, and hair all over the kennel inside and outside of the enclosures. 21.41 a, Needs to put all puppies on the USDA records the same way the adult breeders are kept. 21.41 b, Has an exemption letter to keep records on USDA forms. 21.42 They were not on the state forms and was missing pertinent information. 455.8 Owner is certified to give his own rabies vaccinations (can not find his letter) the rabies records were not complete and accurate there was no way match up the dogs to the records he has.</p>
